 - iv. All tariffs are including VAT
 - v. Standard rate 4.% based on the Inflationary Forecasts as determined through MFMA Circular no. 112 inclusive of VAT
 - vi. Tariffs are applicable throughout INTSIKA YETHU MUNICIPALITY unless indicated otherwise
